The CRA Executive Director provided an update to the Board regarding new information/responses received and discussions of possible settlement numbers with URDG and expected to be completed with a final report by the next Board meeting.

The CRA Executive Director advised a meeting was scheduled for the site remediation issue with REP Associates but was cancelled by URDG. The meeting has been rescheduled for Thursday.

TAB 2 – STATUS UPDATE REGARDING THE CRA COMMERCIAL GRANT PROGRAMS

The CRA Executive Director provided a status update in the Agenda packet of CRA funded Commercial Grant Projects as of January 22, 2010. The CRA Executive Director advised the Board commercial grant projects have been awarded for an amount of 1.2 million dollars, matched with an estimated \$800,000. The CRA Executive Director proposed that the Board open the program to accept additional new applications from March 22nd to April 5th. The CRA Executive Director advised \$250,000 is available for the additional applications.

TAB 3 – STATUS UPDATE REGARDING THE SCHEDULING OF PUBLIC-INPUT WORKSHOPS FOR THE CRA BOARD TO REFINER THE LISTING OF FUNDING PRIORITIES FOR DEBT FINANCING IN AN AMOUNT UP TO \$27 MILLION TO MORE SPECIFICALLY DEFINE AND/OR PRIORITIZE THE REDEVELOPMENT PROJECTS, PROGRAMS AND ACTIVITIES TO BE FUNDED

TAB 4 – PRESENTATION BY HARVEY, COVINGTON & THOMAS, LLC REGARDING THE CRA’s FY 2008-09 INDEPENDENT AUDITED FINANCIAL REPORT

The CRA Executive Director introduced Robert Harvey, Founding Partner with Harvey, Covington & Thomas, LLC, briefed the Board on the audit of the financial statements for September 30, 2009. In his opinion, the financial statements present fairly, in all material respects, the respective financial position of the governmental activities and each major fund of the Agency as of September 30, 2009, and the respective changes in financial position thereof for the fiscal year then ended in conformity with U.S. generally accepted accounting principles. Board discussion regarding recommendations by the firm for improving information technology general controls and recordkeeping for the CRA.
