

RESOLUTION NO. R-8-2006-14

**A RESOLUTION OF THE CHAIRMAN AND BOARD MEMBERS OF THE NORTH MIAMI COMMUNITY REDEVELOPMENT AGENCY, AUTHORIZING THE EXECUTIVE DIRECTOR TO PROVIDE \$15,000 AS REQUESTED BY THE PARTNERSHIP FOR RECOVERY, INC. FOR THE REPAIR OF SIX (6) IDENTIFIED AND APPROVED HOMES THROUGH THE "NO BLUE ROOFS" PROGRAM; AND FURTHER AUTHORIZING THE EXECUTIVE DIRECTOR TO WORK WITH THE PARTNERSHIP FOR RECOVERY, INC. TO PROVIDE ADDITIONAL FUNDS IN AN AMOUNT UP TO \$10,000 FOR ADDITIONAL BLUE ROOF REPAIRS; AND PROVIDING AN EFFECTIVE DATE**

WHEREAS, the North Miami Community Redevelopment Agency (the "CRA") desires to coordinate with the City of North Miami (the "City") and support the ongoing efforts of the Partnership for Recovery, Inc. relative to the implementation of the "No Blue Roofs" Program in the City; and

WHEREAS, the CRA Board desires to accept and support the recommendation contained in the Executive Director's memorandum accompanying this item that is hereby incorporated by reference.

**NOW, THEREFORE, BE IT RESOLVED BY THE CHAIRMAN AND BOARD MEMBERS OF THE NORTH MIAMI COMMUNITY REDEVELOPMENT AGENCY:**

**Section 1.** The recitals in the whereas clauses are true and correct, and incorporated into this Resolution.

**Section 2.** The Executive Director is hereby authorized to provide \$15,000 in funds requested by the Partnership for Recovery, Inc. for roof repairs to six (6) identified and approved homes in the CRA Redevelopment Area within the City through the "No Blue Roofs" Program.


**Section 3.** The Executive Director is hereby authorized to work with the Partnership for Recovery, Inc. to provide additional funds in an amount up to \$10,000 for additional roof repairs to approved homes in the CRA Redevelopment Area within the City through the "No Blue Roofs" Program.


**Section 4.** This resolution shall take effect immediately upon approval.
