

RESOLUTION NO. R-CRA-2009-7

A RESOLUTION OF THE CHAIRMAN AND BOARD MEMBERS OF THE NORTH MIAMI COMMUNITY REDEVELOPMENT AGENCY APPROVING THE FIRST AMENDMENT TO THE INTERLOCAL AGREEMENT BY AND BETWEEN THE CITY OF NORTH MIAMI, FLORIDA AND THE NORTH MIAMI COMMUNITY REDEVELOPMENT AGENCY; AUTHORIZING THE CHAIRMAN AND THE EXECUTIVE DIRECTOR OF THE NORTH MIAMI COMMUNITY REDEVELOPMENT AGENCY TO EXECUTE THE FIRST AMENDMENT TO THE INTERLOCAL AGREEMENT; FURTHER AUTHORIZING THE EXECUTIVE DIRECTOR TO TAKE ANY AND ALL ACTIONS NECESSARY TO IMPLEMENT AND FULFILL THE OBLIGATIONS OF THE NORTH MIAMI COMMUNITY REDEVELOPMENT AGENCY AS PROVIDED THEREIN; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, the City of North Miami, Florida ("City") and the North Miami Community Redevelopment Agency ("CRA") previously entered into that certain Interlocal Agreement dated November 22, 2005 (the "Interlocal Agreement") which, among other things, clarified certain rights and obligations between the parties relative to Tax Increment Financing ("TIF") revenues; and

WHEREAS, the City and CRA desire to amend the Interlocal Agreement in certain respects relative to the TIF revenues to be refunded to the City pursuant to the terms and provisions of the First Amendment to Interlocal Agreement attached hereto as Exhibit "A" and by this reference made a part hereof.

NOW, THEREFORE, BE IT RESOLVED BY THE CHAIRMAN AND BOARD MEMBERS OF THE NORTH MIAMI COMMUNITY REDEVELOPMENT AGENCY:

Section 1. The recitals in the whereas clauses are true and correct, and incorporated into this Resolution.

Section 2. The First Amendment to Interlocal Agreement by and between the City and the CRA in the form attached hereto as Exhibit "A" is hereby approved, together with such other non-material changes acceptable to the CRA Executive Director and approved as to form and legality by the CRA Attorney.

Section 3. The Chairman and the Executive Director of the CRA are authorized to execute the First Amendment to Interlocal Agreement.

Section 4. The CRA Executive Director is authorized to take any and all actions necessary to facilitate the implementation of First Amendment to Interlocal Agreement and the fulfillment of any and all obligations of the CRA as provided therein.

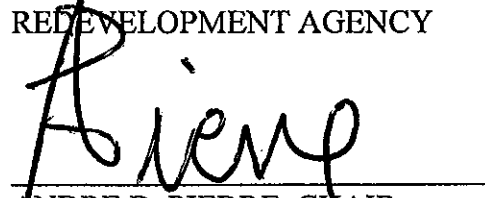
Section 5. This resolution shall take effect immediately upon approval.
